Neus: Een kruidachtige beladen neus wat verandert in zacht rijp fruit met een hint van anijs.

Smaak: Ontwikkelt zich goed met Sinaasappel en andere citrus vruchten.

Afdronk: Erg zacht en afgeronde afdronk met terugkomende kruiden zoals anijs en peper.

Miltonduff has a production capacity of 5.5 million liters. It actually used to be Allied Distillers' largest distillery. Even following Pernod Ricard's takeover of Allied Domecq, the distillery still has one of the largest capacities in the group,

In 1964, a pair of Lomond stills were installed at the distillery in order to start producing the Mosstowie single malt. Ballantine's were responsible for developing the design of the Lomond single malt pot stills, which was one of the reasons that the pot stills were installed at the site. In 1974, a major reconstruction was launched and the number of pot stills was increased. In 1981, the Lomond stills were removed, therefore eliminating the production of Mosstowie. The Lomond stills were replaced by regular pot stills in order to keep up the production levels. In 1986, the majority of the

Hiram Walker stocks were acquired by Allied Domecq, and in 1987, they acquired the rest of the company. In 2005, Pernod Ricard acquired Miltonduff through the corporate merger of Allied and Pernod.

Maltman Longmorn

Neus: fruitige en bloemige neus met zoete geuren.

Smaak: Romig met verse kokos, melk chocolade en gesuikerde amandelen.

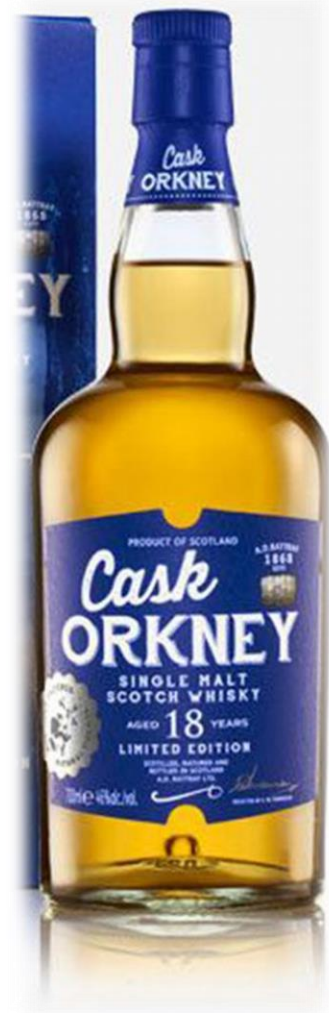
Afdrank: een warme finish met kaneel kruiden en perzik op het eind.

Build on the site of an old chapel, the Longmorn distillery has been founded by John Duff and two associates, Charles Shirres and George Thomson in 1894, together with its neighbour Benriach. John Duff founded the Glenlossie 19 years earlier. The distilleries belonging to "The Chivas and Glenlivet Group", part of Seagram have been bought by the French group Pernod-Ricard on 19 december 2001.

Parts of the production are used in the blends Something Special and Queen Anna.

A.D. Rattray Cask Orkney

18 y.o. 46%



Neus: subtiel en zacht, met groene appel en nootmuskaat, kruidig, zeezout en een lichte tint van rook

Smaak: toffee, perzik en abrikoos, met een rijke zachte textuur, zoete lichte rook en een droge nootachtige afwerking.

Afdronk: Een complexe, lekkere en gebalanceerde whisky!

Highland Park distillery was founded by Magnus Eunson, a butcher and church officer by day and illicit distiller and whisky smuggler by night. In 1798 he was caught illegally distilling whisky on the site. In 1826, nearly 30 years later, Highland Park received an official licence to distill whisky. The name of the distillery does not refer to the Scottish Highlands, but rather to the fact that the distillery was founded on an area called 'High Park' distinguished from a lower area nearby. Highland Park is the only distillery in the world to use Heather peat from Orkney. Exposed to the elements, including gales, few trees survive Orkney's harsh conditions. In the absence of trees, the peat the distillery burns to smoke its hand-malted barley is densely compacted heather dating back 4,000 to 9,000 years. This peat burns slowly, delivering the distinctive aromatic smoke for which the distillery is known.

OWNER: Edrington, formerly known as The Edrington Group, is a privately owned international spirits company based in Scotland. It produces single malts The Macallan, Highland Park, The Glenrothes, and The Famous Grouse blended Scotch whisky.

Càrn Mòr SL Glentauchers

Neus: rijke fruitcake gedompeld in rum en whisky, bessengelei, eikenhout, kruiden en groene druiven.

Smaak: kruiden, gezouten chocolade, mint en kersenjam.

Afdronk: verleidelijk zoet en tegelijk verwarmend.

The family-owned company of Morrison & MacKay is one of the few remnant whisky companies in the Perth area. With its origins in the 1980s, the independent bottler and whisky merchant, which produces a large number of blended whisky brands and individual bottlings, since 2020 is the company now called only Morrisons after Kenny Mackay left the company Glentauchers distillery is a Speyside Scottish whisky distillery, founded in 1897. Glentauchers has long since been associated with blends; it is owned by PERNOD RICARD and is a large component of Ballantines, Teachers and Chivas Regal.

North Star Spirits Auchroisk

Neus: een op olie brandend rayburn fornuis waarin een sinaasappel pudding wordt gebakken.

Smaak: karamel toffees met vers geplukte bramen.

Afdronk: Crêpes suzette met wat extra geraspte mandarijn schil.

The Auchroisk distillery is a whisky distillery owned by DIAGEO in Banffshire, speyside Scotland. It was established after Dorie's Well was discovered and found to have water similar to the water used by the Glen Spey distillery, which was used by Justerini & Brooks to produce malt whisky for their blends. The well's water was used to produce a test batch of whisky at Glen Spey distillery, and was approved, which led to the start of construction of the Auchroisk distillery at the site of the well in 1972 to produce whisky for the J&B blend. Production started in 1974.[2][3]

North Star Spirits is het onafhankelijke label van Iain Croucher (onder meer ex A.D. Rattray) waaronder hij in series (Cask Series) diverse onafhankelijke bottelingen uit brengt. Allen cask strength, non chill filtered en zonder toevoeging van kleurstoffen.

Annandale Man of Word

2015 Nas 60,8% Sherry butt



Neus: volle neus met rozijnen en krenten, sinaasappel en kandijzuiker.

Smaak: aardse vanille met “Jelly Babies”, hop en sinaasappelschil.

Afdronk: verwennend met chocolade biscuit, ananas en witte kruiden.

Het plaatsje Annan ligt in het zuiden (de Lowlands) van Schotland, niet ver van Dumfries. De Annandale Distillery is oorspronkelijk geopend in 1830 door George Donald en vernoemd naar de vallei waar het in “verstopt” ligt. In 1896 werd de distilleerderij gekocht door Johnnie Walker & Sons, die de distilleerderij sloot in 1919 en alles van waarde eruit sloopte. In 2007 kregen de prachtige panden weer een nieuwe toekomst nadat de Annandale Distillery Company onder leiding van David Thompson en zijn vrouw Teresa de gebouwen kochten om daar weer een distilleerderij in te bouwen. Aan

het eind van 2014 kon weer worden begonnen met het stoken.
